In accordance with article 237 of the Constitution of Kenya, Section 23 of TEACHERS SERVICE COMMISSION ACT No. 20 of 2012, it is an offence for any person to engage in the teaching service unless such a person is registered as a teacher. This system provides a platform for online application and registration.

ADVERTISED POSTS
The Commission advertises for vacant posts for teachers. This Online System allows you to apply for any post you qualify and track every stage of processing up to Appointment. **NOTE:** If you apply Online, you don't need to submit a hard copy. No payment is required. Teachers are not expected to register again with the Commission.

ENTRY / EXIT RETURNS
These are returns filed by head teachers, administrators or authorized officers entrusted with responsibility by the Commission for onward processing at the Head Office. They enable proper communication on issues like interdiction, injunction, suspension etc. (Only accessible when logged in by Head of Institution).

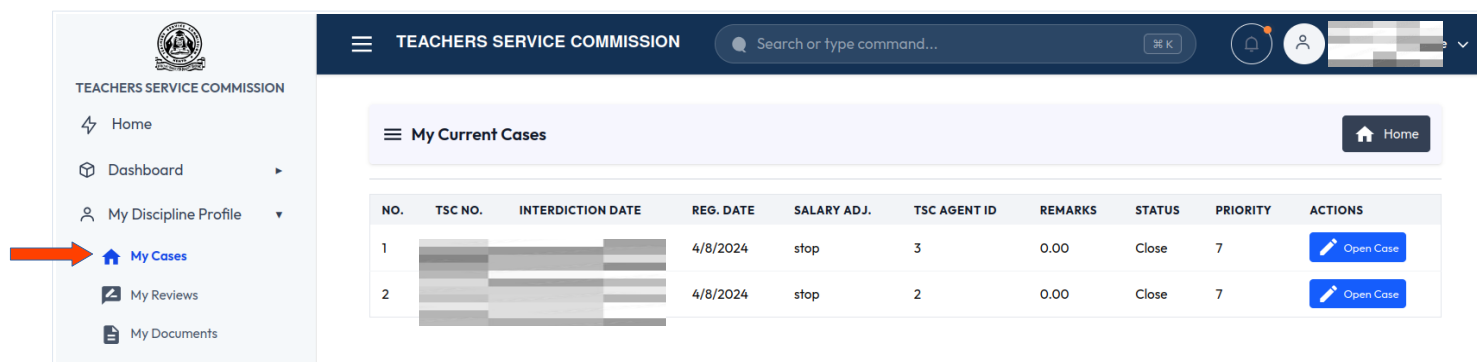

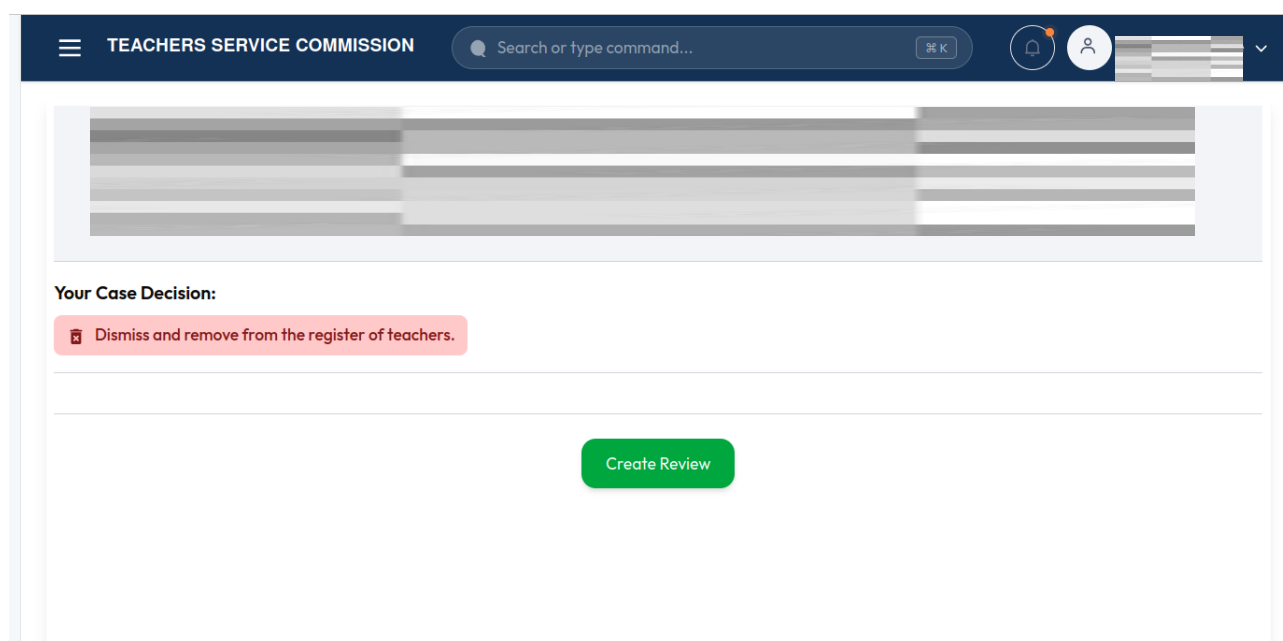
